- 5. The school is required to construct the partition in boys urinals. One CWSN toilet is seen in the boys washroom. The school must make provision for CWSN toilet in girls washroom as well. Separate toilets for CWSN, boys and girls should be procided for on every floor.
- 6. Besides the ramp at the entrance of the building the school should construct a ramp or install a lift for CWSN to access the upper floors.
- 7. The school is required to submit the compliance in r/o condition mentioned of sl. no. 02 to 06 within 03 months on SARAS portal failing which due action will be taken.
